**SHOW CAUSE NOTICE**

(Form-4 CPC R/W Sec-20 (1) & (2) of the RTI Act, 2005.

To,

**The PIO-Cum-DPDO  
District Panchayat Development Officer  
District: Lower Subansiri District, Ziro (AP).**

**WHEREAS**, Shri K.L. Nayam and Libi Marde filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 03.09.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-235/2021, wherein, alleging against you that you have failed to furnish information sought by the Appellant under Form-A of his application dated 08.04.2021 relating the matter as quoted in Form-A application.

**WHEREAS**, you, being PIO-Cum-DPDO, Ziro, District: Lower Subansiri, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section-1 of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

**WHEREAS**, the date of 8<sup>th</sup> hearing of the Appeals was intimated to you in advance but you were found absent during the hearings without giving any intimation to the Commission the reasons of your absence. Moreover, you failed to furnish correct/complete informations to the Appellant till 8<sup>th</sup> hearing which was held on 20<sup>th</sup> June 2022. The Commission seriously viewed the absence of the PIO and found liable for imposing reasonable penalty of your negligence in furnishing of the informations as sought by the Appellant and displayed defiance attitude against the directions of the Commission.

**NOW THEREFORE**, you are hereby directed to appear in person before the Commission (APIC), Itanagar for hearing and to furnish the replies of Show-Cause Notice issued against you on or before **8<sup>th</sup> August 2022 at 1000 hrs** as why you should not be imposed a reasonable penalty as per the Section 20 sub-section (1) of the RTI Act for violation of Sub Section (1) of the Section 7 of the RTI Act, 2005.
