**ORDER**

Whereas, the 6<sup>th</sup> hearing was held on 11<sup>th</sup> April, 2022. The Appellant Smti Kasimang Jopir and DLSRO-Cum-PIO were present during the hearing.

Heard both the parties.

Whereas, the Commission asked Appellant whether she has received remaining informations from the PIO as per the direction given by the Commission in last hearing dated on 14<sup>th</sup> February, 2022. The Appellant informed the Commission that till date the PIO has not furnished informations to her.

Whereas, the Commission seriously viewed on the reluctance shown by the PIO in furnishing the informations to the Appellant inspite of repeated directions given by the Commission to the PIO in every hearing but he failed to furnish the correct and authentic informations as sought by the appellant which establishes prima-facie evidence of violation of Sub Section-1 of Section 7 of the RTI Act, 2005.

Now, therefore the Commission invoked **Sub Section 1 Section 20 of the RTI Act,2005 and imposed penalty of Rs. 25,000/- (rupees twenty-five thousand) only against the PIO for violation of Sub Section-1 of Section 7 of the RTI Act, 2005** and not complying with the orders of the Commissions /Court against the **Appeal No. 241/2021**. Further the PIO is directed to **compensate Rs 10000/- (rupees ten thousand) only** to the Appellant for the monetary losses incurred on to and fro journey expenses due to delay in furnishing of informations and caused harassment to the Appellant

The PIO is directed for personal appearance before the Commission on next date of hearing i.e. 23<sup>rd</sup> May,2022 at 1000 hrs, failing which Sub Section-2 of Section 20 shall be invoked against the PIO. Further, the PIO is also directed to furnish copy of the treasury challan deposit of the penalty to the Commission office along with all the remaining informations as sought by the Appellant during next date of hearing.

No formal notice be served to both the Parties as the next date of hearing is already intimated to both the parties.

Next date of hearing fixed on 23<sup>rd</sup> May, 2022 at 1000 hrs.
