ORDER

Appellant Mr. Tana Roma Tara is absent, PIO shri K.B Chandran is present.

Heard The PIO. During the course of hearing the PIO has informed the commission that reply to RTI application dated 20.07.2021 had been furnished to the Appellant, stating that information sought by the Appellant is covered under section 8 (1) (d) and (h) of the RTI Act,2005 and hence, cannot be furnished. The PIO has also stated that all the documents were sized by SIT (Vig) on 24.06.2016 in connection with SIC (VIG) P.S.G.D No. 40 dated 09.06.2016 and are still under SIT custody. He has further stated that the matter is subjudice as the case is still pending at Hon'ble Bombay High Court in the case no. UP 2730 of 2016 between APIDFCL & Development companies of Maharashtra.

Upon perusal of records it appears that the PIO had appropriately/ timely responded to the present RTI application. The PIO vide his reply dated 10^{th} August, 2021 refused to furnish the information citing section under 8(1)(d)(e) and (h) of the RTI Act, 2005. However, the commission is of the view that justice is not possible without hearing the Appellant.

In view of the above the hearing is adjourned to 21.01.2022 at 10:30 hrs. Notice be issued to both the parties.
