**ORDER**

**Whereas**, an appeal under Section 19(3) of RTI Act, 2005 had been received from Shri Tai Talley, Gohpur-Tinali, PO R.K. Mission, PS. Itanagar, Itanagar. Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Deptt. of PWD, Sangram Division, Kurung Kumey District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 30/11/2021 regarding **C/o 2 lane road from BRTF Road to Layang under CRF Scheme.**

**Whereas**, three hearings were held and in the 3<sup>rd</sup> hearing held on 9<sup>th</sup> August' 2022, the appellant, Shri Tai Talley was found absent without any prior intimation. Therefore, the case was disposed of presuming that the Appellant is satisfied with the information furnished by the PIO in the 2<sup>nd</sup> hearing held on 28<sup>th</sup> June, 2022.

The Appellant appeared before the State Chief Information Commissioner on 29<sup>th</sup> August'2022 and informed that due to sudden demise of his son on the day of hearing i.e. 9<sup>th</sup> August'2022 he could not appear in the court nor could intimate the Commission. He also informed that the PIO has not furnish all the information as sought by him in the Form-A Dated 24/01/2022. Therefore, he appealed the Commission to review the case.

**Whereas**, the Commission in view of the genuine appeal of the Appellant decided to have a review on the case. The Appellant is asked to make a list of information not furnished by the PIO as sought by him in the Form-A Dated 24/01/2022 and serve a copy to the PIO at the earliest. The PIO is directed to bring authenticated Xerox copies of all the information as listed by the Appellant in the date of hearing. In case, if information sought are not available, the PIO is directed to give in writing the reasonable reasons for unavailability of the information. So, that the case can be disposed in the date of hearing.

**The date of review hearing is fixed on 11<sup>th</sup> Octobe'2022.**

**Therefore**, the PIO-cum-EE(PWD), Govt. of A.P., Deptt. of PWD, Sangram Division, Kurung Kumey District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
