**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tai Talley, Gohpur-Tinali, PO R.K. Mission, PS. Itanagar, Itanagar. Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Deptt. of PWD, Sangram Division, Kurung Kumey District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 30/11/2021 regarding C/o 2 lane road from BRTF Road to Layang under CRF Scheme.

Whereas, the 1<sup>st</sup> hearing was held on 17<sup>th</sup> May, 2022 at 1030hrs as scheduled. PIO-cum-EE(PWD), Govt. of A.P., Deptt. of PWD, Sangram Division, Kurung Kumey District, Arunachal Pradesh was found absent during the hearing. However, Shri Bini Tare, Incharge RTI Cell, Sangram Division PWD represented the PIO. The Appellant shri Tai Talley was present. The representative of the PIO informed the Commission that they have not received the Form-A of the Appellant but after receiving the Notice of Hearing from the Commission, the representative have collected all the information regarding the scheme for which information have been sought. The Appellant informed that the application Form- A dated 24/01/2022 has been received by a J.E. Sangram Division PWD.

Whereas, the Commission on scrutiny found that the Form-A have been received by the J.E. Sangram Division PWD. However, the representative of the PIO was asked to take a click of the Form-A dated 24/01/2022 and furnish all the information free of cost to the Appellant before the next date of hearing. The representative of the PIO agreed to comply with the order of the Commission and informed that all the information shall be furnished to the Appellant within 25<sup>th</sup> June'2022. The Commission asked the Appellant to receive the information and convey his satisfaction or dissatisfaction in the next date of hearing.

**Whereas, the 2<sup>nd</sup> hearing was held on 28<sup>th</sup> June' 2022 at 1030hrs as scheduled.** Shri N. Tada, the PIO-cum-EE(PWD), Govt. of A.P., Deptt. of PWD, Sangram Division, Kurung Kumey District, Arunachal Pradesh and the Appellant Shri Tai Talley were present during the hearing. The PIO furnished the information to the Appellant during the Court hearing. Upon going through the forwarding note of the PIO, all the available information were furnished and reasons were given for the information which are not available with the PIO.

After receiving the information so furnished, the Appellant appealed the Commission to fix a new date of hearing, so as to go through the information.

**Whereas,** the Commission directed the PIO to attend next date of hearing to guide the Appellant in case of any confusion. The Commission also asked the Appellant to go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

**The next date of hearing is fixed on 9<sup>th</sup> August' 2022 at 1030hrs.**

**Therefore,** the PIO-cum-EE(PWD), Govt. of A.P., Deptt. of PWD, Sangram Division, Kurung Kumey District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
