**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June & Shri Abang Yangfo, C/o Hotel Chandini, E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, Govt. of A.P., o/o Deputy Commissioner, Itanagar, Capital Complex, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/12/2021 regarding Land Allotment sketch Map/NOC Town Planning / NOC Disaster Management/NOC (UD)/ under (DC) Capital Complex (A.P).

Whereas, the 1<sup>st</sup> hearing was held on 13<sup>th</sup> September, 2022 at 1030hrs as scheduled. Shri T. Kechak, the Public Information Officer, Govt. of A.P., o/o Deputy Commissioner, Itanagar, Capital Complex, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The Appellant informed the Commission that the PIO has furnished information for the Sl.no. 1, i.e. total name list of land allotment at Capital Complex but have not furnished other information as sought in the Sl.no. 2, 3, 4, 5, & 6 and their details. The Appellant informed that he actually need the information to understand the procedure of the land allotment laid down by the government and followed by the applicants to procure the land allotment. The Appellant also informed that he does not require information for Sl.no. 4. i.e. ST/PRC/Aadhar Card of the land allotment applicants. The PIO informed that the information sought are voluminous, some are old, not clear, and concerns to third party.

Whereas, the Commission directed the PIO to furnish the samples of the information sought by the Appellant, as the Appellant required the information to know the procedure of the land allotment. Also, the Commission directed the PIO to observe **Section 11 of the RTI Act 2005**, if the information sought pertains to third party information. The Commission asked the Appellant to visit the office, have inspection of the information and seek specific information which are required by him from the PIO. The Appellant agreed to do so. The Commission asked both the parties to follow the directions and submit their reports to the Commission within a week from the date of issue of this order. The Commission fix a date of hearing to confirm the satisfaction of the Appellant.

**The next date of hearing is fixed on 29<sup>th</sup> November' 2022 (Tuesday) at 1030hrs.**

Therefore, the The Public Information Officer, Govt. of A.P., o/o Deputy Commissioner, Itanagar, Capital Complex, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
