**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June & Shri Abang Yangfo, C/o Hotel Chandini, E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, Govt. of A.P., o/o Director Agriculture, Naharlagun, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 15/12/2021 regarding appointment of DAO/ADO/AFA/ of entire district of Arunachal Pradesh under Director of Agriculture Department.

Whereas, the 1<sup>st</sup> hearing was held on 13<sup>th</sup> September, 2022 at 1030hrs as scheduled. Shri Ojong Yomso, the PIO-cum-Jt. Director, Govt. of A.P., o/o Director Agriculture, Naharlagun, Arunachal Pradesh and the Appellant Shri Abang Yangfo were present during the hearing. The Appellant informed the Commission that the PIO has not furnished any information. The PIO informed that the information were kept ready but the Appellant did not turn up to collect the same. The information were brought in the court and handed over to the Appellant free of cost with a receipt. The Appellant appealed the Commission to give time to go through the information and he shall inform the commission of his satisfaction or dissatisfaction within a week.

Whereas, the Commission giving reasonable time to the Appellant to go through the information asked him to convey his satisfaction or dissatisfaction before the next date of hearing.
