Heard Sri G. Hazarika, DC, Pakke Kessang. During the course of hearing Sri G. Hazarika, DC, Pakke Kessang appearing on behalf of the ADC-Cum-PIO, has informed the commission that the information sought by the Appellant has not been furnished by ADC-Cum-PIO.

The Appellant Mr. Nabam Ashok has informed that he has not yet received reply to his RTI application dated 15.05.2021. He has also appealed to the commission to pass appropriate order directing the ADC-Cum-PIO to furnish complete information.

After hearing the Appellant, it is noted that the PIO has not dealt with the present RTI application appropriately and in time bound manner. It is further, observed that the PIO cannot deny any information which is permissible under the law.

With the above observation the PIO is directed to furnish the requested information to the Appellant within 15 days from today.
