ORDER

The appellant vide his RTI application dated 29.12.2021 sought information on 15 points as contained therein.

The PIO did not provide any reply to the appellant in response to the present RTI application. The appellant then filed a first appeal. The FAA also did not response to the appeal. The appellant thereafter, filed a second appeal before the commission with a request to provide complete information.

The appeal is heard today. Both the PIO and appellant are absent. However, Mr. Abang Yangfo appears for the appellant.

Mr. Abang Yangfo, appearing for the appellant, informs the commission that the PIO has not furnished reply to the appellant.

Upon perusal of records it appears that the appellant has sought information on various schemes/works undertaken by the department. Names of these schemes and works are not mentioned in his RTI application. RTI application completely lacks focus. Therefore it is not possible for the Commissiobn to order for full disclosure of the information sought by the appellant. However, considering the request of the appellant made through Mr. Abang yangfo, the PIO is directed to furnish only copies of the sanction order of works/schemes under SADA,SIDF and CAMPA carried out by the department in Upper Subansiri District. Information shall be provided within 15 days from the receipt of this order.

Hearing is adjourned to 05.08.2022.

Both the appellant and PIO are directed to appear in person during the hearing on the above mentioned date.
