ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE (Hydro Power), Govt. of A.P., Deptt. of Hydro Power, Ziro, Lower Subansiri District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 11/01/2021 regarding implementation of schemes and Fund Sanctioned under, SADA, SIDF, RE, CSS, Supply, maintenance, state share, of entire Lower Subansiri, Kamle, Kra Dadi and Kurung Kumey.

Whereas, the 1<sup>st</sup> hearing was held on 17<sup>th</sup> May'2022 at 1030hrs as scheduled. The PIO-cum-EE (Hydro Power), Govt. of A.P., Deptt. of Hydro Power, Ziro, Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that the PIO has not furnished any information. Since, the PIO was absent the Commission could not hear from the PIO.

Whereas, the Commission viewed seriously the **absenting** of the PIO from performing the **statutory duty** without any prior information. The Commission giving reasonable opportunity to the PIO decided to fix next date of hearing. **If the PIO is found absent in the next date of hearing. The Commission shall be compelled to impose penalty on the PIO U/S 20(1) of the RTI Act 2005.**

The next date of hearing is fixed on 28<sup>th</sup> June' 2022 at 1030hrs.

Therefore, **The PIO-cum-EE (Hydro Power), Govt. of A.P., Deptt. of Hydro Power, Ziro, Lower Subansiri District, Arunachal Pradesh** is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
