After hearing the appellant and perusal of record, this commission directs the PIO to provide complete and correct information to the appellant within 20 days from the receipt of this order.

With the above direction, matter is again posted on August 12th, 2022.

The PIO is directed to be present during the hearing on the above mentioned date.
