GIST OF ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Kipa Hano, C-Sector, PO/PS Itanagar, E-Sector, Naharlagun, Arunachal Pradesh for nonfurnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 18/01/2022 regarding C/o Road from Sango to Lungsa at the Estimate Cost of Rupees 350.00 lakh only no. SPWD/PE-06/YCC/2-17-18/31 dtd. 8/2/2018.

hearing was held on 20th September'2022 at 1030hrs as Whereas, the 1st scheduled. Shri Takam Langdip, the PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Arunachal Pradesh and the Appellant Shri Kipa Hanok were present during the hearing. The appellant informed the Commission that the PIO has not furnished information as sought for by him. The PIO informed that the RTI Application of the Appellant is not received and available in the office. Further informed that after receiving the summon from the Commission the effort were made to trace out the application but not found. However, the Form-A, Dated 18/01/2022 was made available to the PIO and the PIO assured to furnish all the information within a months' time.

Whereas, the Commission directed the PIO to furnish all the information within four weeks time from the date of issue of this order. The PIO agreed to comply with the order of the Commission. The Commission also ask the Appellant to receive the information from the PIO and go through the information and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 15th November' 2022 at 1030hrs.
