**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tapu Mibang, Village Mopung, PS-Rumgong, Siang District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-DDSE, Govt. of A.P., Changlang District, Deptt. of Education, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 23/10/2021 regarding information related to Teaching & Non-Teaching staff.

**Whereas, the 1<sup>st</sup> hearing was held on 14<sup>th</sup> June'2022 at 1030hrs as scheduled.** Shri Ego Doye, The PIO -cum- DDSE, Changlang, District Changlang was present during the court hearing. Shri Tapu Mibang, Appellant was absent. Shri Ego Doye, informed the Commission that he had furnished all the information copies to the Appellant and WT Message vide No. ED/ESTT/RTI/20-21 Dated 28/04/2022 addressed to Registrar, APIC office regarding information related to Teaching And Non Teaching staff of the DDSE.
