**ORDER**

The appellant is present. The PIO is absent.

Heard the parties present.

During the hearing the appellant has informed that no information has been furnished despite commission order dated 03.06.2022 and 12.08.2022.

The commission by order dated 03.06.2022 and 12.08.2022 directed the PIO to furnish lists of works carried out by the department under JJM Schmes in West Kameng district. The PIO has neither appeared before the commission nor furnished the information to the appellant. It is observed that such omission on the part of the PIO to carry out the direction of the commission in furnishing the information to the appellant reflects disrespect towards the RTI, Act itself.

The commission, therefore, directs PIO to comply with the order issued on 03.06.2022 and 12.08.2022 within 15 days from the issue of order, failing which penal action may be taken against you under section 20(1) of the RTI, Act.

With the above direction, matter is adjourned to **December 2<sup>nd</sup>, 2022**.

The PIO is directed to be present during the hearing on the above mentioned date.
