ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-DDSE, Govt. of A.P., Deptt. of Education Khonsa, Tirap District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 25/01/2022 regarding appointment of SSA/ISSE/RMSA/ of entire Tirap District.

Whereas, the 1st hearing was held on 21st June, 2022 at 1030hrs as scheduled. The PIO-cum-DDSE, Govt. of A.P., Deptt. of Education Khonsa, Tirap District, Arunachal Pradesh and the Appellants Shri Tania June, & Shri Abang Yangfo were found absent during the hearing. However, the PIO vide WT Message Dated 17/06/2022 informed the Commission that he is unable to attend the hearing due to direction of the State Government for compulsory participation of the Head of Departments for the International Yoga Day Celebration. The PIO also informed that the information sought by the Appellant are ready to be furnish on deposit of requisite fees. The PIO appealed the Commission to fix another date of hearing. The Appellant, Shri Abang Yangfo vide letter no NIL Dated 21/06/2022 informed the Commission that he is unable to attend the hearing on medical ground and also appealed to fix another date of hearing.

Whereas, the Commission in consideration of the appeals of the PIO and the Appellant decided to fix next date of hearing.

Whereas, the 2nd hearing was held on 9th August' 2022 at 1030hrs as scheduled. Shri Hortum Loyi, the PIO-cum-DDSE, Govt. of A.P., Deptt. of Education Khonsa, Tirap District, Arunachal Pradesh and the Appellants Shri Abang Yangfo were present during the hearing. The PIO brought the information and furnished the same to the Appellant. The Appellant appealed the Commission to give one week time to go through the information.

Whereas, the Commission giving reasonable opportunity to the Appellant asked him to go through the information and convey his satisfaction or dissatisfaction before the next date of hearing.

The next date of hearing is fixed on 6th September' 2022 at 1030 hrs.

Therefore, the PIO-cum-DDSE, Govt. of A.P., Deptt. of Education Khonsa, Tirap District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
