ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-DDSE, Govt. of A.P., Deptt. of Education Changlang, Changlang District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 25/01/2022 regarding appointment of SSA/ISSE/RMSA/ of entire Changlang District.

Whereas, the 1st hearing was held on 21st June, 2022 at 1030hrs as scheduled. The PIO-cum-DDSE, Govt. of A.P., Deptt. of Education Changlang, Changlang District, Arunachal Pradesh and the Appellants Shri Tania June & Shri Abang Yangfo were found absent during the hearing.
