**ORDER**

The appellant vide his RTI application dated 24.01.2022 sought information on 07 points as contained therein.

The PIO vide his letter dated 28.03.2022 provided the information to the appellant in response to the present RTI application. Dissatisfied with the PIOs reply the appellant filed a first appeal. The FAA did not response to the appeal. The appellant thereafter, filed a second appeal before the commission with a request to provide complete information.

The appellant Tapu Mibang is present. PIO is absent.

Heard the appellant.

During the hearing the appellant has stated that the PIO has only furnished the information sought in point no. (1), (2) and (4) and that the information sought in point no. (2), (5),(6) and (7) has not been furnished so far. He has further stated that information relating to details of persons and their appointment letters so furnished by the PIO is incomplete.

The commission after hearing the submission of the appellant hereby directs the PIO to furnish the remaining information to the appellant within 15 days from the issue of order.

With the above direction hearing is adjourned to 07<sup>th</sup> October, 2022.

The PIO is directed to be present during the hearing on the above mentioned date.
