**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Mewang Lowang, Borduria Village, PO/PS Borduria, Tirap District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-DFO, Govt. of A.P., Forest Deptt, Tirap District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 19/01/2022 regarding fund sanctioned, approved and released under Centrally and State sponsor schemes.

**Whereas, the 1<sup>st</sup> hearing was held on 21<sup>st</sup> June, 2022 at 1030hrs as scheduled.** Shri P.Tangha, the PIO-cum-DFO, Govt. of A.P., Forest Deptt, Tirap District, Arunachal Pradesh and the Appellant Shri Mewang Lowang were present during the hearing. The PIO informed the Commission that the information sought by the Appellant at Sl.o. 3 & 4 of the Form-A dated 19/01/2022 is not under his purview and the same statement is given in writing to the Appellant. The information sought by the Appellant at Sl.no. 1 & 2 has been sent through registered post in the address of the Appellant and also copies of information already furnished have handed over to the Appellant. The Appellant after going through the information furnished by the PIO, informed the Commission that the information furnished by the PIO is not complete.

**Whereas**, the Commission after hearing from both the parties, directed the PIO to furnish the complete information to the Appellant, get the receipt and intimate the Commission. The Commission also asked the Appellant to receive the information and convey his satisfaction or dissatisfaction before the next date of hearing.

**The next date of hearing is fixed on 9<sup>th</sup> August' 2022 at 1030 hrs.**

**Therefore, the PIO-cum-DFO, Govt. of A.P., Forest Deptt, Tirap District, Arunachal Pradesh** is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
