GIST OF ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tech Lali & Shri Tech Rakap, Nyikum Colony, Nirjuli/Sopo vill.Doimukh, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Yupia Division, Arunachal Pradesh as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 18/01/2022 regarding construction / implementation of supply works TMT, cement, GI pipes, Pipe fitting items under JJM scheme from 2019 to till date under Yupia PHE Division.

Whereas, the 1st hearing was held on 20th September'2022 at 1030hrs as scheduled. Shri Swant Riang, the PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Yupia Division, Arunachal Pradesh was present during the hearing.
