## GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Techi Lali & Shri Techi Rakap, Nyikum Colony, Nirjuli/Sopo vill.Doimukh, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Yupia Division, Arunachal Pradesh as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 18/01/2022 regarding construction / implementation of supply works TMT, cement, GI pipes, Pipe fitting items under JJM scheme from 2019 to till date under Yupia PHE Division.

Whereas, the 1<sup>st</sup> hearing was held on 20<sup>th</sup> September'2022 at 1030hrs as scheduled. Shri Swant Riang, the PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Yupia Division, Arunachal Pradesh was present during the hearing. The Appellant Shri Techy Lali & Shri Techi Rakap were absent. The PIO informed the Commission that all the information has been furnished to the Appellant. The Appellant also on Whatsapp informed that information has been received from the PIO. But, the Appellant has not confirmed as to whether he is satisfied.

Whereas, the Commission giving reasonable opportunity to the Appellant fix one more date of hearing. If the Appellant fails to appear in the next date of hearing the case shall be disposed of with presumption that the Appellant is satisfied with the information so furnished by the PIO.

Whereas, the Re-scheduled 2<sup>nd</sup> hearing was held on 15<sup>th</sup> November, 2022 at 1030hrs. The PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Yupia Division, Arunachal Pradesh, the Appellants Shri Techy Lali and Shri Techi Rakap were found absent during the hearing.

Whereas, the Commission observed that the information has been furnished to the Appellant by the PIO but the Appellant has not confirmed his satisfaction. Therefore, the Commission giving reasonable last opportunity to the Appellant decided to fix one more date of hearing. If, the Appellant fails to appear in the hearing the case shall be disposed of presuming that the Appellant is satisfied with the information.

The next date of hearing is fixed on 20<sup>th</sup> December, 2022 (Tuesday) 1030hrs.

Therefore, the PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Yupia Division, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
