**ORDER**

The appellant Mr. Suraj Ligu is present. Er. Toko Ottu, SE-cum-PIO, Rural Works Circle, Ziro is present. SE-cum-PIO, Rural Works Circle, Rupa is absent. SE-cum-PIO, Rural Works Circle, Itanagar is, though absent, represented by Mr. Ngilyang Tatu, Tracer.

Er. Purpa Tsering EE-cum-PIO, RWD Tawang Division, Er. Karbom Basar, EE-cum-PIO, RWD Sinchung Division, Er. Vijay Singh Thakur EE-cum-PIO, RWD, Lumla Division, Er. T. Rai, EE-cum-PIO, RWD Daporijo/ Dumporijo division are present. EE-cum-PIO, RWD Ziro Division is, though absent, represented by Shri. Tamchi Wadia, JE. EE-cum-PIO, RWD, Raga division is, though absent, represented by Er. Toko Ottu. EE-cum-PIO, RWD, Yupia/Poma division is, though absent, represented by APIO Yangbiu Lika, AE.

EE-cum-PIO, RWD, Sagalee Division, EE-cum-PIO, RWD, Seppa Division, EE-cum-PIO, RWD, Chayangtajo Division, EE-cum-PIO, RWD, Bameng division, EE-cum-PIO, RWD, Pakke-Kessang, EE-cum-PIO, RWD, Jamin Division, EE-cum-PIO, RWD, Laaying Yangte are absent.

I have heard the parties present.

During the course of hearing Mr. Ngilyang Tatu, Tracer, representative of SE-cum-PIO Rural Works Circle, Itanagar has stated that they had already issued letter to the EE of the concerned sub-divisions to furnish the requisite information to the appellant.

SE-cum-PIO, Rural Works Circle, Ziro Er. Toko Ottu while attending the hearing informed the commission that all the PIO's-cum-EE's under his circle have come with the requisite information sought by the appellant except EE-cum-PIO RWD, Jamin. He also informed the commission that PIO-cum-EE, Jamin will also furnish the information within one week.

With the permission of the commission EE-cum-PIO RWD, Daporijo/Dumporijo and Kamle has furnished the information to the appellant in soft copy as well as hard copy. EE-cum-PIO RWD, Ziro too has furnished the information to the appellant in hard copy. He has also assured that information in soft copy will be furnished to the appellant.

EE-cum-PIO RWD, Sinchung Division while attending the hearing has informed that information had already been furnished to the appellant. EE-cum-PIO RWD, Lumla

Division has stated that he has furnished the information in soft copy to the appellant except Comparative Chart and has assured that he will furnish the same before next date of hearing. EE-cum-PIO RWD, Tawang division has furnished the information in soft copy to the appellant. EE-cum-PIO RWD, Poma/Yupia division has stated that he had already furnished the information to the appellant.

The appellant who appears in person during the hearing has informed that the information furnished by the EE- cum-PIO RWD, Lumla, Yupia/Poma and Tawang are incomplete. He has requested the EE-cum-PIO RWD, Lumla, Tawang and Yupia/Poma to furnish soft copy of financial bids ( BOQ) which was uploaded online by the tendererss and soft copy of Comparative Chart (BOQ).

The commission after hearing the submissions made by the parties present hereby directs the PIO-cum-EE, Lumla, Tawang, Poma/Yupia to furnish the remaining information to the appellant before next date of hearing. The commission further directs the PIO-cum-EE, RWD Sagalee, Seppa, Chayangtajo, Bameng, Pakke-Kessang, Jamin, Laaying Yangte to furnish the correct and complete information to the appellant within 20 days from the issue of order.

The SE-cum-PIO, Rural Works Circle, Rupa, Itanagar and Ziro shall also direct the EE-cum-PIOs of their respective jurisdiction to furnish the information in reply to the RTI application without further delay.

With the above direction, matter is adjourned to September 23<sup>rd</sup>, 2022.

All the PIOs and appellant are directed to be present during the hearing on the above mentioned date.


