GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Sangte Jokhio & Shri Bengia Kak, Karsingsa Secment-2, PO/PS Banderdewa, Papum Pare District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Naharlagun Division, Arunachal Pradesh as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 31/01/2022 regarding Appointment & DPC of the Employee.

Whereas, the 1st hearing was held on 20th September'2022 at 1030hrs as scheduled. Shri Gebuk Burang, the PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Naharlagun Division, Arunachal Pradesh and the Appellants, Shri Sangte Jokhio & Shri Bengia Kak, were present during the hearing. Adv. Ebo Mili appearing for the Appellants informed the Commission that the PIO has denied information and did not furnish. The PIO informed that due to leave of the dealing assistant the information could not be furnished on time. The PIO brought information in the court and handed it over to the Appellants. The Advocate of the Appellants appeal the commission to give time to go through the information and convey his satisfaction or dissatisfaction.

Whereas, the Commission on appeal of the Advocate of the Appellants, giving reasonable opportunity decided to fix one more date of hearing.

Whereas, the 2nd hearing was held on 15th November, 2022 at 1030hrs. Shri Gebuk Burang, the PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Naharlagun Division, Arunachal Pradesh and the Appellants, Shri Sangte Jokhio & Shri Bengia Kak, were present during the hearing. Adv. Octu Mangay appearing for the Appellants informed the Commission that the PIO has not furnished complete information and also the information so furnished are not authenticated with CTC.

Whereas, the Commission on scrutiny found that all the information as sought by the Appellant in the Form-A has been furnished to the Appellant by the PIO. However, the CTC was done by the PIO. The Commission directed the PIO to furnish all the information with CTC. The PIO agreed to comply with the direction of the Commission. The commission for the confirmation of satisfaction of the Appellant decided to fix one more date of hearing.

The next date of hearing is fixed on 20th December, 2022 (Tuesday) at 1030hrs.

Therefore, **The PIO-cum-EE(PHE & WS), Govt. of A.P., Deptt. of PHE & WS Naharlaung Division, Arunachal Pradesh** is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
