GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tamchi Tamak, Last Damsite, Near Govt. Pry. School, Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(HPD), Govt. of A.P., Deptt. of Hydro Power, Koloriang, Arunachal Pradesh as sought for by the Appellant under section 6(1) of RTI Act, 2005 on 25/02/2022 regarding Kush MHS (2x1000kw) Sangram.

Whereas, the 1st hearing was held on 20th September'2022 at 1030hrs as scheduled. Shri Darmar Ete, the PIO-cum-EE(HPD), Govt. of A.P., Deptt. of Hydro Power, Koloriang, Arunachal Pradesh was present during the hearing. The Appellant Shri Tamchi Tamak was found absent. The PIO informed the Commission that he has not received the Form-A, application of the Appellant. However, the Form-A application was made available to the PIO and assured to furnish all the information.

Whereas, the Commission giving reasonable opportunity to the PIO directed him to furnish all the correct and complete information to the Appellant as sought in the Form-A within four weeks form the date of issue of this order. The Commission also giving reasonable opportunity to the Appellant and to hear from him decided to fix one more date of hearing. If the Appellant fails to appear in the next date of hearing the Commission shall disposed of the case with presumption that the Appellant is no more interested in the information.

The next date of hearing is fixed on 22nd November, 2022 at 1030hrs.

Therefore, The PIO-cum-EE(HPD), Govt. of A.P., Deptt. of Hydro Power, Koloriang, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
