- 2) **Whether any bills pending under the work name C/o Drop inlet Headwork, at Osumpuri village during 2018-2020.**
- 3) **Furnish the name of the firm & proprietor/Contractor of the providing water supply at village Saji and Osumpuri, during 2018-2020 with cheque no. and total amount issued to person concerned.**
