ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Likha Tassar & Shri Lishi Bekhi, Near Tadar Tamar Fair Price Shop, Pachin Colony, PO/PS Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(RWD), Ziro Division, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 27/02/2022 regarding PMGSY from new Pania to Neuliber.

Whereas, the 1st hearing was held on 9nd August' 2022 at 1030hrs as scheduled. The PIO-cum-EE(RWD), Ziro Division, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Likha Tassar was present. However, Shri Tamchi Wadie, J.E. (RWD), ZIRO Division represented the PIO. JE informed the Commission that the Appellant was asked to deposit Rs.5, 000/- through Treasury Challan but the Appellant did not turn up. The Appellant informed that it was intimated only after the application of the 2nd Appeal and the detail information was not given for the charges of the information.

Whereas, the Commission going through the Form-A receipt date and date of intimation served to the Appellant found that the PIO has acted diligently. However, the Commission directed the PIO to give detail list of the information and its accurate amount to the Appellant. The Commission also asked the Appellant to deposit the requisite amount through the Treasury Challan and receive the information from the office of the PIO and convey his satisfaction or dissatisfaction before the next date of hearing.

The next date of hearing is fixed on 6th September' 2022 at 1030 hrs.

Therefore, the PIO-cum-EE(RWD), Ziro Division, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
