ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Likha Tassar & Shri Abang Yangfo, Near Tadar Tamar Fair Price Shop, Pachin Colony, PO/PS Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Yazali Division, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 14/02/2022 regarding C/o Bridge over river Panyor to connect village of left and right bank of Panyor river in Lower Subansiri District under CRIF.

Whereas, the 1st hearing held on 9nd August' 2022 at 1030hrs as scheduled. The PIO-cum-EE(PWD), Govt. of A.P., Yazali Division, Lower Subansiri District, Arunachal Pradesh is found absent during the hearing. However, Shri T.L. Teil, the APIO-cum-AE (PWD) Yazali Division, represented the PIO. The Appellant informed the Commission that even after deposit of the fee for the information through Treasury Challan information has not been furnished. The APIO, informed that the information were kept ready but the Appellant has not come to collect the information from the office. The information were brought in the court and furnished to the Appellant. The Appellant appealed the Commission to give some time to go through the information.
