**ORDER**

The appellant is, though absent, represented by Shri. Logo Natung. PIO is absent. I have heard the parties present.

During the course of hearing Shri. Logo Natung has informed the commission that PIO has not furnished the information sought in point no. (a), (g) and (h) despite commission order dated 19.08.2022 directing him to provide correct and complete information within 15 days from the issue of order.

The commission by order dated 19.08.2022 directed the PIO to furnish the information sought in point no. (a), (g) and (h) within 15 days from the issue of order as the RTI application of the appellant was not transferred to the concerned BDOs. APIO-Cum-PIO can obtain the sought information after seeking assistance of the concerned BDOs under section 5(4) of the RTI Act, 2005. It is again ordered that the onus is on the PIO to obtain the required information and provide it to the appellant.

The PIO shall comply with the order of the commission within 15 days from the issue of order

With the above direction, **matter is adjourned to December 9<sup>th</sup>, 2022.**

Both the appellant and PIO are directed to be present during the hearing on the above mentioned date.
