**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, & Shri Abang Yangfo, C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-District Panchayat Development Officer, Govt. of A.P., Raga, Kamle District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 26/10/2021 regarding Fund/Financial sanction and approved being 1<sup>st</sup> and 2<sup>nd</sup> installment basic grants under 14<sup>th</sup> Finance commission of Kamle District.

**Whereas, the 2<sup>nd</sup> hearing was held on 15<sup>th</sup> February'2022 at 1030hrs as scheduled.** The PIO-cum-District Panchayat Development Officer, Govt. of A.P., Raga, Kamle District, Arunachal Pradesh was found absent during the hearing.
