ORDER

The appellant vide his RTI application dated 22.04.2022 sought information on 10 points as contained therein.

The PIO did not provide any reply to the appellant in response to the present RTI application. The appellant then filed a first appeal. The FAA also did not response to the appeal. The appellant thereafter, filed a second appeal before the commission with a request to provide complete information.

The appeal is heard today. Appellant is absent. PIO Mr. Hibu Tama is present.

During the course of hearing the PIO has stated that he had furnished the information relating to Technical Sanction Oder. He has also stated that information regarding Geo Tag, Measurement book, Bills Abstracts, UC and CC details can only be provided after completion of the work. He has further stated that information sought in Point No. 9 cannot be provided as the funds are in PFMS mode.

The commission, after hearing the submission made by the PIO, observes that since the fund under CMSSY is released in three instalments i.e 50%, 25% and 25% respectively in the month of August, December and February, the PIO should have furnished the Utilization Certificate, Measurement Books, Bills Abstract, Geo Tagging Photographs, PFMS etc of the first phase or second phase of works as the case be completed at the time of submission of the RTI application. The commission therefore, does not fully agree with the contention of the PIO that above said information can be provided only after the completion of the work. The PIO is, therefore, directed to furnish correct and complete information on or before **next date of hearing fixed on 07.10.2022**

Both the PIO's and appellant are directed to be present during the hearing on the above mentioned date.
