**GIST OF ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Likha Tassar, Near Tadar Tamer Fair Price shop, Pachin Colony, Naharlagun, Papum Pare District. Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(RWD), Govt. of A.P., Ziro-Division, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 02/03/2022 regarding Kimin Ziro BRTF Road to Pistana.

Whereas, the 1<sup>st</sup> re-scheduled hearing was held on 11<sup>th</sup> October 2022 (Tuesday) at 1030hrs as scheduled. Shri Gambi Karbak, the PIO-cum-EE(RWD), Govt. of A.P., Ziro-Division, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Likha Tassar were present during the hearing. The Appellant informed the Commission that the PIO has not furnished any information. The PIO informed that the information sought by the Appellant were kept ready and an intimation was served to the Appellant to deposit a sum of Rs. 5,000/- as processing charges of the information. The PIO further stated that the information is voluminous. However, the PIO could not give the accurate nos of pages for which he was charging.

Whereas, the Commission directed the PIO to intimate the correct number of pages, make accurate amount and intimate to the Appellant to deposit the charges through Treasury Challan. The Commission asked the Appellant to pay the charges for the information through Treasury challan and receive the information from the PIO. The Appellant is also asked to collect the information, go through and convey his satisfaction or dissatisfaction in the next date of hearing.

**The next date of hearing is fixed on 13<sup>th</sup> December' 2022(Tuesday) at 1030 hrs.**

Therefore, The PIO-cum-EE(RWD), Govt. of A.P., Ziro-Division, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
