SUMMON NOTICE

Whereas, Shri Tania June filled the Second Appeal against you before the Arunachal Pradesh Information Commission, Itanagar, on 25.10.2021 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-385/2022, wherein, alleging against you that you have failed to furnish information sought by him under Form-A of his application dated 22.09.2021 regarding appointment of UDC, LDC, Peon, Chowkider, Sweepers and Drivers Contingency MTS and under establishment DC office Tato.

Whereas, you being PIO-O/o the Deputy Commissioner, Shi-Yomi District, Tato, Arunachal Pradesh have refused to furnish the information sought under RTI Act, 2005 to the appellant within the prescribed period of 30 days from the date of receipt of his application as provided under Sub-Section (1) of Section-7 of the Act without any reason, whereby, amounting to violation of the said sub-section of section-7, liable for imposing reasonable penalty against you under sub section (1) of section-20 of the Act.

Whereas, hearing notice of the Appeal was sent to your through registered AD vide No. EE4144610031IN dated 4th December, 2021 for your appearance before the Court for hearing on 31st January, 2022 but you were found absent during the hearing without giving any intimation to the Commission.

Therefore, the Commission directed you to appear before the Commission in person during the next date of hearing along with all the informations as sought by the appellant, failing which Section 18 (3) of the RTI Act, 2005 shall be invoked against the PIO. Next date of hearing fixed on 14th March, 2022 at 10:00 hrs.
