ORDER

The appellant vide his RTI application dated 01.07.2022 sought information on 15 points as contained therein.

The PIO on 7th July,2022 furnished reply to the appellant in response to the present RTI application. The appellant then filed a first appeal. The FAA also did not response to the appeal. The appellant thereafter, filed a second appeal before the commission with a request to provide complete information.

The PIO, who appears before the commission, has submitted that he furnished his reply on 07-07-2022. He has further informed that after delivery of his letter dated 07-07-2022, realizing that there was mistake in the calculations made in arriving at the amount of fees, he had revised his decision as to the amount of fees, and revised fees as determined by him was also intimated to the appellant/complainant on 01-08-2022.

The appellant/complainant is not present to contest the submission of the PIO.

After hearing the PIO and perusal of record, the commission considers the relief cannot be allowed to the appellant and justice is not possible without hearing. Hence, the hearing is adjourned to **09-12-2022** give opportunity of hearing to the appellant/complainant.

Both the PIO and the appellant/complainant shall appear before the commission on the next date of hearing.
