ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from **Shri Ha Tago, & Shri Charu Taha, C/o Anti-Corruption, Kra-Daadi District Unit, Hakum Village, Nirjuli, PO/PS Nirjuli, District Papum Pare, Arunachal Pradesh** for non-furnishing of information by **The PIO-cum-Executive Engineer(PWD),Jamin Division, District Kra Daadi, Arunachal Pradesh,** as sought by the Appellant under section 6(1) of RTI Act, 2005 on 20/09/2021 regarding **C/o Road from Dari to Chambang, CO Hq in Kra Daadi District under NESIDS.**

Whereas, the rescheduled 1st hearing was held on 8th March, 2022 at 1030hrs. The PIO-cum-Executive Engineer (PWD),Jamin Division, District Kra Daadi, Arunachal Pradesh, was found absent during the hearing. However, the APIO-cum-AE(PWD), Shri Sunil Degio, represented the PIO. The Appellant Shri Ha Tago was present. The appellant informed the Commission that the PIO has not furnished any information as sought by him in the Form-A Dated 20/09/2021. The APIO informed that the information sought by the Appellant is of ongoing work and furnishing of the information may hamper the work progress. So, the same was not furnished. In support of his argument, he referred to a decision / order of case No. APIC 417/2012, where in it reads that "As per the mandates of RTI Act, the information can be assessed which is complete and over. The information which is not yet complete and over, such information cannot be provided."

Whereas, the Commission directed the PIO to furnish all the information which are complete, available, and accessible to the Appellant within fifteen days from the date of issue of this order. The APIO agreed to comply with the Commission's direction. The Commission also asked the Appellant to receive the information, and go through the same enabling him to convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 29th March, 2022 at 10:30 hrs.

Therefore, **The PIO-cum-Executive Engineer (PWD), Jamin Division, District Kra Daadi, Arunachal Pradesh**, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
