## ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, President (AAVS) & Shri Abang Yangfo, AGS(AAVS), C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-District Panchayat Development Officer, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 26/10/2021 regarding Fund/Financial sanction and approved being 1<sup>st</sup> and 2<sup>nd</sup> installment basic grants under 14<sup>th</sup> Finance commission of Upper Subansiri District.

Whereas, the 1<sup>st</sup> hearing was held on 15<sup>th</sup> February'2022 at 1030hrs as scheduled. Shri M. Loyi, the PIO-cum-District Panchayat Development Officer, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh was present during the hearing. The Appellant Shri Tania June was found absent. However, the 2<sup>nd</sup> Appellant Shri Abang Yangfo represented the 1<sup>st</sup> Appellant Shri Tania June. The PIO informed the Commission that the information were kept ready within the prescribed stipulated period and the Appellant was intimated vide letter no. DRJ/DPDO/RTI-01/2021-22/171 Dated Daporijo the 22<sup>nd</sup> Nov'2021 to deposit fees for the information and collect the same. But the Appellant did not turn up to collect the information. The 2<sup>nd</sup> Appellant Shri Abang Yangfo appealed the Commission that the information should be furnished free of cost as the PIO have failed to furnish information within the prescribed period of thirty days from the date of submission of the 'Form-A' application.

Whereas, the Commission made it clear that as per the evidences furnished by the PIO, the reply has been done within the prescribed period, so the Appellant has to pay the fee for the information through Treasury Challan and receive the same. The Appellant agreed to pay the fee and receive the information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2<sup>nd</sup> hearing was held on 19<sup>th</sup> April' 2022 at 1030hrs as scheduled. Shri M. Loyi, the PIO-cum-District Panchayat Development Officer, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that he did not receive any information from the PIO.

Whereas, the Commission giving reasonable opportunity to the Appellant to receive information as directed in the last hearing held on 15<sup>th</sup> February'2022. The Commission asked the Appellant to pay fee for the information through Treasury Challan and receive information from the PIO. The Appellant is also asked to convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 3<sup>rd</sup> hearing was held on 24<sup>th</sup> May' 2022 at 1030hrs as scheduled. The PIO-cum-District Panchayat Development Officer, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh, the Appellants Shri Tania June and Shri Abang Yangfo were found absent during the hearing was present.

Whereas, the Commission in view of the 2<sup>nd</sup> hearing held on 19<sup>th</sup> April'2022, gives the Appellant a final reasonable opportunity to receive the information from the office of the PIO after depositing the requisite fee for the information through treasury challan. If the Appellant fails to receive the information from the PIO's office it will be presumed that the Appellant is no more interested in the information and the case shall be disposed of in the next date of hearing.

The next date of hearing is fixed on 5<sup>th</sup> July '2022 at 1030hrs.

**Therefore,** Shri M. Loyi, The PIO-cum-District Panchayat Development Officer, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
