**ORDER**

**Whereas, an appeal under Section 19(3) of RTI Act, 2005 have been received from Shri Huri Tadong, S/o Shri Huri Kaha, Vill-Loak, PO-Damin, PS-Koloriang, District Kurung Kumey, Arunachal Pradesh. [C/o Shri Lokam Mangha, Assistant Food Controller, Govt. of A.P., Directorate of Health Naharlagun] for non-furnishing of information by Shri Nangbia Tada, The PO-cum-Executive Engineer, PWD Sangram Division, Govt. of A.P., Kurung Kumey District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 10/09/2021 regarding c/o office-cum- residential building at SIB, Huri under Damin circle.**

**Whereas, the rescheduled 1<sup>st</sup> hearing was held on 8<sup>th</sup> March, 2022 at 1030hrs. The PIO-cum-Executive Engineer (PWD) Sangram Division, Govt. of A.P., Kurung Kumey District, Arunachal Pradesh was found absent during the hearing. However, Shri Dongda Tadok, APIO-cum-AE(PWD) Koloriang Sub Division and the Shri Bini Tare, in-charge RTI cell represented the PIO. The Appellant Shri Huri Tadong was present. The Appellant informed the Commission that the PIO has not furnished any information sought by him in the Form-A Dated 10/09/2021. The APIO informed that the information sought by the Appellant is related to SIB i.e. Intelligence Bureau so the same could not be furnished.**

Whereas, the Commission made it clear to the APIO that the information pertaining to the infrastructure development activities or construction activities of any Intelligence Department does not come under any exemption section of RTI Act 2005. The Commission directed the APIO to furnish all the information sought by the Appellant in the 'Form-A' Dated 10/09/2021. The APIO agreed to comply with the order of the Commission. The Commission also asked the Appellant to receive the information, go through it and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 26<sup>th</sup> April, 2022 at 1030hrs.

Therefore, Shri Nangbia Tada, The PO-cum-Executive Engineer, PWD Sangram Division, Govt. of A.P., Kurung Kumey District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
