## ORDER

Vs

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tamchi Tamak, C/o Gida Tapung, 2 Kilo, Papu Nallah, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh, as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 20/10/2021 regarding c/o five nos double lane RCC bridge between Sangram to Nyapin.

Whereas, the 1<sup>st</sup> hearing was held on 15<sup>th</sup> February'2022 at 1030hrs as scheduled. The PIO was found absent during the hearing. However, Shri Bini Tare, in-charge RTI cell, Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh, represented the PIO. The Appellant shri Tamchi Tamak was present. The representative of the PIO informed the Commission that all the information are ready to be furnished except for the copy of Approved NIT, it shall be provided soon after receipt from the Division office. The Appellant appealed the Commission to fix one more hearing date as he would need time to go through the information.

Whereas, the Commission directed the PIO to furnish complete & correct information to the Appellant and the Commission giving reasonable time to the Appellant to go through the information decided to fix next date of hearing.

Whereas, the 2<sup>nd</sup> hearing was held on 19<sup>th</sup> April, 2022 at 1030hrs as scheduled. The PIO was found absent during the hearing. However, Shri Bini Tare, in-charge RTI cell, Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh, represented the PIO. The Appellant shri Tamchi Tamak was present. The representative of the PIO informed that the PIO is on leave and is at Delhi on medical ground. The copy of information along with the original copy was brought in the court. The Appellant refused to receive the information as the information brought by the PIO were simple copies without any authentication.

Whereas, the Commission directed the representative of the PIO to get CTC on all the Xerox copies of the information and hand it over to the Appellant. The representative of the PIO agreed to do so. Also, the Commission asked the Appellant to receive the information and convey his satisfaction or dissatisfaction in the next date of hearing.

The next date of hearing is fixed on 24<sup>th</sup> May' 2022 at 1030 hrs.

Therefore, The PIO-cum-EE(PWD), Govt. of A.P., Sangram Division, Kurung Kumey District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
