ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, President (AAVS) & Shri Abang Yangfo, AGS(AAVS), C/o Hotel Chandini E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by The PIO-cum-District Panchayat Development Officer, Govt. of A.P., Jamin, Kradaadi District, Arunachal Pradesh as sought, by the Appellant under section 6(1) of RTI Act, 2005 on 26/10/2021 regarding Fund/Financial sanction and approved being 1st and 2nd installment basic grants under 14th Finance commission of Kradaadi District.

Whereas, the 1st hearing was held on 15th February'2022 at 1030hrs as scheduled. Shri Rido Tasar, the PIO-cum-District Panchayat Development Officer, Govt. of A.P., Jamin, Kradaadi District, Arunachal Pradesh was present during the hearing. The Appellant Shri Tania June was found absent. However, the 2nd Appellant Shri Abang Yangfo represented the 1st Appellant. The Appellant informed the Commission that he has not received any information from the PIO. The PIO informed the Commission that after receiving the RTI Application from the Appellant he had been availing leave so could not furnish information in time, but now the information as sought by the Appellant are kept ready to be furnished on payment of fees through Treasury Challan.

Whereas, the Commission directed the PIO to furnish all the information free of cost to the Appellant as the PIO did not furnish the information within the prescribed time period. The Commission asked the Appellant to receive the information and convey his satisfaction or dissatisfaction in the next date of hearing.

Whereas, the 2nd hearing was held on 19th April, 2022 at 1030hrs as scheduled. Shri Rido Tasar, the PIO-cum-District Panchayat Development Officer, Govt. of A.P., Jamin, Kradaadi District, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Abang Yangfo was present. The Appellant informed the Commission that he has not received the information from the PIO.

Whereas, the Commission made it clear that in the last hearing held on 15th February '2022 the PIO had been directed to furnish information free of cost to the Appellant. The PIO also had informed that the information are kept ready to be furnished to the Appellant. The commission asked the Appellant to receive information from the PIO. Giving reasonable opportunity to the Appellant the Commission decided to fix one more date of hearing.

Whereas, the 3rd hearing was held on 24th May, 2022 at 1030hrs as scheduled. Shri Rido Tasar, the PIO-cum-District Panchayat Development Officer, Govt. of A.P., Jamin, Kradaadi District, Arunachal Pradesh, the Appellants Shri Tania June and Shri Abang Yangfo was found absent during the hearing.

Whereas, the Commission in view of the 2nd hearing held on 19th April '2022, giving a final reasonable opportunity to the Appellant to receive the information from the office of the PIO decided to fix one more date of hearing. If the Appellant fails to receive the information from the PIO's office, it will be presumed that the Appellant is no more interested in the information and the case shall be disposed of in the hearing.

The next date of hearing is fixed on 5th July '2022 at 1030hrs.

Therefore, Shri Rido Tasar, the PIO-cum-District Panchayat Development Officer, Govt. of A.P., Jamin, Kradaadi District, Arunachal Pradesh hereby summoned to appear before this Court in person on the scheduled date and time without fail.
