GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tai Abu, Gangte line, Sangram, Kurung Kumey District, Arunachal Pradesh for non-furnishing of information by The Public Information Officer, Govt. of A.P.,O/o the Chief Engineer (CSQ), Public Works department, Itanagar, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 23/05/2022 regarding contractor enlistment of M/s Kakum Enterprises vide registration no. CEAP (CSQ)/W-48/2015-16/154, Dat 30/12/2015.

Whereas, the 1st re-scheduled hearing was held on 11th October 2022 (Tuesday) at 1030hrs as scheduled. Shri Rimar Taso, the Public Information Officer, Govt. of A.P.,O/o the Chief Engineer (CSQ), Public Works department, Itanagar, Arunachal Pradesh and the Appellant Shri Tai Abu were present during the hearing. The Appellant informed that the PIO has furnished information for the Sl.no. i & iii as sought by him but have not furnished the information for the Sl.no. ii. The PIO informed that the information sought at Sl.no. ii pertains to 3rd party and the third party has denied to furnish information to the Appellant, so, the PIO has not furnished the information to the Appellant.

Whereas, after hearing from both the parties, the Commission giving reasonable opportunity to the third party decided to summon the third party (proprietor of M/s Kakum Enterprises) in the next date of hearing. If the third party fails to give a written submission or appear in person during the hearing, it will be presumed that the third party (proprietor of M/s Kakum Enterprises) has no objection in furnishing of the information to the Appellant and the Commission shall make a decision as to whether or not to disclose the information and direction shall be given to the PIO accordingly.

The next date of hearing is fixed on 22nd November' 2022(Tuesday) at 1030 hrs.

Therefore, The Public Information Officer, Govt. of A.P.,O/o the Chief Engineer (CSQ), Public Works department, Itanagar, Arunachal Pradesh, and Smt. Yanang Bengia (the proprietor of M/s Kakum Enterprises), Opposite Govt. ME School 'D' Sector, Bengia Building, IG partk, Itanagar are hereby summoned to appear before this Court in person on the scheduled date and time without fail.


