ORDER

Whereas, an appeal under section 19(3) of RTI Act, 2005 has been received from Shri Bawansu Pul, Butcher Line, Tezu Bazaar, Lohit District, Arunachal Pradesh for non furnishing of information by the PIO-cum-EE(PHE&WS) Hawai Division, Anjaw District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI, Act,2005 on 16/03/2022 regarding the Augmentation of W/S under Jal Jeevan Mission Project of Kheyong Village, Hawai Circle, Anjaw District, Arunachal Pradesh amounting to Rs 27.78 Lakhs.

Whereas, the first hearing of this case was held on 31/08/2022. Both the Appellant and the PIO was present. Heard both the parties. The Appellant informed the Commission that he has not received any information from the PIO. On this the Commission directed the PIO to furnish all the informations to the appellant within one week and he should inform the Commission. The PIO assured to provide the same within no time. The next date of hearing of this case is fixed on 28/09/2022.

Whereas, the second hearing of this case was held on 28/09/2022. The representative of the PIO Er Nyomi Nyodu, AE, PHE&WS was present during the hearing and the representative of the Appellant Shri Roshman Tawsik of Nukung Village was also present. Heard both the Parties. The representative of the Appellant has informed that the information furnished by the PIO is incomplete. On this the Commission has directed the PIO/APIO to furnish all the remaining documents (Sanction order copy of JJM project of Kheyong Village amounting to Rs 27.78 Lakhs, completion report, DPR, GPS reading, Geo-tagging, Photographs, under whose supervision the concerned AE/JE the work were implemented) to the appellant.

The next date of hearing of this case is fixed on 16/11/2022 at 1030 AM.

Therefore, the PIO-cum-EE(PHE&WS) Hawai Division, Anjaw District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time failing which the Commission shall be compelled to impose penalty against the PIO u/s 20(1) of the RTI Act, 2005.
