GIST OF ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Bamang Tagung, Press Colony, Papu Nallah, Po/Ps- Naharlagun, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. of PHE & WS, Ziro Division, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 20/04/2022 regarding detail information of an amount of Rs. 100.00 lakhs (Rupees one crores) transfer of fund under NDRF through PFMS-EAT Model against your saving A/C (4717101002225) at Canara Bank Ziro, IFC Code; (CNRB0004717) for the financial year 2018-19.

Whereas, the 1st re-scheduled hearing was held on 11th October 2022 (Tuesday) at 1030hrs as scheduled. The PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. of PHE & WS, Ziro Division, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Bamang Tagung were found absent during the hearing. Since both were absent, the Commission could not hear from them.

Whereas, the Commission viewed seriously the absenting of the PIO from performing statutory duty without any prior reasonable intimation. The PIO is directed to furnish all the information as sought by the Appellant free of cost within 15(fifteen) days from the issue of this order and to be present in person in the next date of hearing, failing which the Commission may be compelled to impose **penalty under Section- 20(1) of the RTI Act 2005 against the PIO** and the same shall be published in the wide circulating Newspapers with name and designation of the PIO. Also, if the Appellant remains absent in the next date of hearing without any prior reasonable intimation, the Commission shall disposed of the case presuming that the Appellant is no more interested in the information.

The next date of hearing is fixed on 13th December' 2022(Tuesday) at 1030 hrs.

Therefore, the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. of PHE & WS, Ziro Division, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.


