**GIST OF O R D E R**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Bamang Tagung, Press Colony Papu Nallah, Po/Ps- Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. of PHE & WS, Kodukha Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 20/04/2022 regarding amount Rs. 100.00 Lakhs (Rupees one crores) transfer of fund under NDRF through PFMS-EAT Model against your saving A/C No.38224156703 at SBI Bank Daporijo, IFC Code; (SBIN0005818) for the financial year 2018-19.

**Whereas, the 1<sup>st</sup> hearing was held on 15<sup>th</sup> November, 2022 at 1030hrs as scheduled.** The the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. of PHE & WS, Kodukha Division, Upper Subansiri District, Arunachal Pradesh and the Appellant Shri Bamang Tagung, were found absent during the hearing. As, both the parties were absent, the Commission could not hear arguments.

**Whereas,** the Commission viewed seriously the absenting of the PIO from performing the statutory duty without any prior intimation. If the PIO is found absent in the next date of hearing the Commission may be compelled to imposed penalty of **Rs. 25, 000/- (Rupees twenty five thousand ) only u/s 20(1) of the RTI Act 2005** and the same shall be published in the wide circulating Newspaper with name and designation of the PIO. Further, if the Appellant fails to appear in the next date of hearing without any prior intimation or any reasonable reasons, the Commission shall dispose of the case presuming that the Appellant is no more interested in the information as sought by him to the PIO.

The next date of hearing is fixed on 20<sup>th</sup> December'2022 at 1030 hrs.

Therefore, the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. of PHE & WS, Kodukha Division, Upper Subansiri District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
