**Whereas**, an appeal under section 19(3) of RTI Act, 2005 has been received from Shri Tana Roma Tara, Lower Emchi Village, Near IOC Doimukh, Papumpare District, Arunachal Pradesh for non furnishing of information by the PIO-cum-EE(PHE&WS) Anini Division, Dibang Valley District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI, Act,2005 on 06/05/2022 regarding LoC/LoA & placement of fund under JJM, PHE&WS Anini Division, AP since 2018 till date.

**Whereas**, the first hearing of this case was held on 31/08/2022. The Appellant was present but the PIO was absent. Therefore, the case couldn't be heard. Hence, the Commission has fixed the next date of hearing of this case on 28/09/2022.

**Whereas**, the second hearing of this case was held on 28/09/2022. The Appellant was present but the PIO was absent. The Appellant informed the Commission that he has not received any information from the PIO. The Commission viewed seriously the absenting of the PIO from performing the statutory duty without any prior information. The Commission giving reasonable opportunity directs the PIO to attend the Court in the next date of hearing. Failing which the Commission shall be compelled to impose penalty against the PIO u/s 20(1) of the RTI Act, 2005.

**The next date of hearing of this case is fixed on 16/11/2022 at 1030 AM.**

**Therefore**, the PIO-cum-EE (PHE&WS) Anini Division, Dibang Valley District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without out.


