GIST OF O R D E R

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tana Roma Tara, Lower Emchi, PO & PS-Doimukh, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. PHE & WS, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 06/05/2022 regarding LOC/LOA & Placement of Fund under JJM.

Whereas, the 1st re-scheduled hearing was held on 11th October 2022 (Tuesday) at 1030hrs as scheduled. The PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. PHE & WS, Longding Division, District Longding, Arunachal Pradesh was found absent during the hearing. The Appellant Shri Tana Roma Tara was present. The Appellant informed the Commission that the PIO has not furnished any information as sought by him. Since, the PIO was absent the Commission could not hear from him.

Whereas, the Commission viewed seriously the absenting of the PIO from performing statutory duty without any prior reasonable intimation. The PIO is directed to furnish all the information as sought by the Appellant free of cost within 15(fifteen) days from the issue of this order and to be present in person in the next date of hearing, failing which the Commission may be compelled to impose **penalty under Section- 20(1) of the RTI Act 2005 against the PIO** and the same shall be published in the wide circulating Newspapers with name and designation of the PIO. The Commission asked the Appellant to receive information from the PIO and convey his satisfaction or dissatisfaction before the next date of hearing.

The next date of hearing is fixed on 13th December' 2022(Tuesday) at 1030 hrs.

Therefore, by the PIO-cum-EE(PHE & WS), Govt. of A.P., Dept. PHE & WS, Longding Division, District Longding, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
