**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Techi Gumin, Sangri Colony Doimukh, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the PIO-cum-DFO, Govt. of A.P., Dept. of Forest, Sagalee Division , Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 17/05/2022 regarding implementation of NPV component of state CAMPA AOP during 2020-2021 in respect of Sagalee Forest Division.

Whereas, the Commission had fixed the date of hearing on 18<sup>th</sup> October'2022 but due to unavoidable circumstances the date has been Re-scheduled to 15<sup>th</sup> November'2022 (Tuesday) at 1030 hrs in the Hon'ble Court of Shri Rinchen Dorjee, the State Chief Information Commissioner, Arunachal Pradesh Information Commission, Itanagar.

**Whereas, the Re-scheduled 1<sup>st</sup> hearing was held on 15<sup>th</sup> November, 2022 at 1030hrs as scheduled.** Shri Kalung Bida, the PIO-cum-DFO, Govt. of A.P., Dept. of Forest, Sagalee Division, Papum Pare District, Arunachal Pradesh and the Appellant Shri Techi Gumin were present during the hearing. The Appellant informed the Commission that the PIO did not furnish any information and even did not attend the hearing of the FAA. Also, the the PIO did not comply with the direction of the FAA.

The PIO informed that he received summon letter of FAA only after the hearing date so could not attend the FAA's court. However, the information are ready and brought to be furnished to the Appellant. The Appellant received the information and appealed the Commission to give time to go through the same.

**Whereas,** the Commission directed the PIO to furnish complete information as sought by the Appellant and satisfactory reasons may be given in writing if information are not available. The PIO agreed to comply with the direction of the Commission. The Commission giving reasonable opportunity to both the parties decided to fix next date of hearing.

**The next date of hearing is fixed on 20<sup>th</sup> December, 2022 (Tuesday) at 1030 hrs.**

**Therefore, the PIO-cum-DFO, Govt. of A.P., Dept. of Forest, Sagalee Division, Papum Pare District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.**
