The third party may also choose to be present through its dully authorised representative for hearing or they may also file a written submission before the commission before the hearing.

**6.** The authorised representative of the PIO/Appellant/Complainant/Third party is advised to carry a proof of identity along with the authorisation letter.

7. Take notice that in default of your appearance on the time and date mentioned aforesaid the case shall be heard and decided in your absence and that there will be no adjournment and review.
