**SHOW CAUSE NOTICE**



1. **Whereas**, one Shri Abang Yangfo & Shri Rai Lamra have filed the Second Appeal against the PIO-cum-Executive Engineer (PWD) Naharlagun Division, Arunachal Pradesh, before the Arunachal Pradesh Information Commission, Itanagar on 18/08/2022 U/S 19(3) of RTI Act, 2005 vide Appeal No. APIC-506/2022, wherein, alleging against the concerned PIO that he has failed to furnish information sought by him under 'Form A' of his application dated 25.05.2022 relating to the matter as quoted in Form-A application.
2. **Whereas**, the case is still ongoing in the Commission's Court, during the last hearing of this case held on 21<sup>st</sup> Sept, 2022 the APIO has brought the information sought for furnishing to the appellant and the same has been allowed. However, the Commission seriously viewed the delay in providing the information sought by the appellant and to show cause as to why you should not be imposed a reasonable penalty provided in Sub-Section (1) of the Section 20 of RTI Act, 2005 of having violated Sub-Section (1) of Section 7 of the RTI Act, 2005 failing which the matter will be heard ex-parte.
3. **Therefore**, you are once again directed to appear in person on **02<sup>nd</sup> Nov, 2022 at 1030 hrs** alongwith the replies of Shaw Cause before the Commission (APIC).
