**GIST OF ORDER**

**ORDER**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Longto Wangpan, Zedua Village, PO/PS-Longding, Longding District, Arunachal Pradesh for non-furnishing of information by the PIO-cum-EE(PHED), Govt. of A.P., PO/PS-Longding, Longding District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 27/04/2022 regarding all the ongoing work with name of the scheme / programme under PHED, Longding, Longding Division, Govt. of Arunachal Pradesh.

**Whereas, the 1<sup>st</sup> hearing was held on 25<sup>th</sup> October' 2022at 1030hrs as scheduled.** Shri Tage Nipa, the PIO-cum-EE(PHED), Govt. of A.P., PO/PS-Longding, Longding District, Arunachal Pradesh and the Appellant Shri Longto Wangpan were present during the hearing. The appellant informed the Commission that he PIO has not furnished any information. The PIO informed that due to miscommunication with the clerk and staff the information could not be furnished in time.
