As per RTI Act, 2005. All universities and college established by law made by parliament or by state legislature or by notification by the appropriate government or owned, controlled or substantially finance directly or indirectly by fund provided by the government shall come within the meaning of a Public Authority under this act. So, we appeal kindly to furnish authenticate document.**

Whereas, the Commission is satisfied that there are reasonable grounds to hear and dispose of the said appeal under the provisions of Rights to Information Act, 2005.
