GIST OF ORDER

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tania June, C/o Hotel Chandini, E-Sector, Naharlagun, Arunachal Pradesh for non-furnishing of information by the PIO-cum-DPDO, Govt. of A.P.,Deptt. of Pancayati Raj, Ziro, Lower Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 17/05/2022 regarding Expenditure & Implementation of under Cluster Farming of entire Lower Subansiri District.

Whereas, the Commission is satisfied that there are reasonable grounds to hear and dispose of the said appeal under the provisions of the Right to Information Act, 2005. The hearing for the said appeal is fixed on 25th October' 2022 at 1030 hrs in the Hon'ble Court of Shri Rinchen Dorjee, the State Chief Information Commissioner, Arunachal Pradesh Information Commission, Itanagar.

Whereas, 1st hearing was held on 25th October'2022 at 1030hrs. Shri J.D. Prasad, the APIO, Govt. of A.P.,Deptt. of Pancayati Raj, Ziro, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Tania June were present during the hearing. The APIO informed that all the information has been furnished to the appellant except for Utilization Certificate (UC). The same shall be furnished to the Appellant within 31st October'2022.

Whereas, the Commission giving reasonable opportunity to the APIO to furnish the Utilization Certificate (UC) directed the APIO to furnish the same before the 31st October'2022. The Commission also asked the Appellant to receive the information and convey his satisfaction or dissatisfaction in writing before the next date of hearing.

The next date of hearing is fixed on 22nd November, 2022 at 1030 hrs.

Therefore, the PIO-cum-DPDO, Govt. of A.P., Deptt. of Pancayati Raj, Ziro, Lower Subansiri District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
