**GIST OF O R D E R**

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Shri Tai Tahar & Shri Ha Tago, Qtr.No-14, T-II, Chanra Nagar, Itanagar, Arunachal Pradesh for non-furnishing of information by the PIO-cum-DDSE, Govt. of A.P., O/O Deputy Director of School Education, Palin, Kra-Daadi District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 on 11/03/2022 regarding Detail information of Govt. Girls Residential Schools of Kra-Daadi District from 2019 to till date.

**Whereas, the 1<sup>st</sup> hearing was held on 1<sup>st</sup> November' 2022 at 1030hrs as scheduled.** The PIO-cum-DDSE, Govt. of A.P., O/O Deputy Director of School Education, Palin, Kra-Daadi District, Arunachal Pradesh and the Appellant Shri Tai Tahar were found absent during the hearing. However, Shri Taniang Kimo, APIO-cum-DPC, ISSE represented the PIO. The APIO informed the Commission that the information sought by the Appellant could not be furnished in time due to frequent shifting of office building, as the DDSE Kra Daadi does not have it's own permanent office building. However, the APIO assured that the information shall be furnished to the Appellant within a week.

**Whereas,** the Commission giving reasonable opportunity to the PIO directs him to furnish all the available information as sought by the Appellant within a week from the issue of this order and if the information are not available the PIO has to give in writing the reasonable satisfactory explanation to the Appellant. The Commission also directs the Appellant to

receive information from the PIO and convey his satisfaction or dissatisfaction before the next date of hearing. A caution is also given to the Appellant to appear in the next date of hearing. Failing which the Commission may dispose of the case presuming that the Appellant is no more interested in the information.

**The next date of hearing is fixed on 20<sup>th</sup> December' 2022 at 1030 hrs.**

Therefore, the PIO-cum-DDSE, Govt. of A.P., O/O Deputy Director of School Education, Palin, Kra-Daadi District, Arunachal Pradesh, is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
